These staff work together to create a seamless system of service, intervention and advocacy that support the unique needs of the client. Interpreting services are available every day and include: American Sign Language, deaf-blind interpreting and other non-verbal and oral communication, and C-Print, which is computer-generated captioning that supports total access to and involvement with the class, meeting or other environment. Mental Health/Community Support Program provides home-based mental health and community support services for deaf and hard-of-hearing clients; eliminating isolation and supporting.
